Our approach works because it integrates with existing 'best practices' recovery approaches and is led by a well-recognized entity that is located in your community already. Put simply, we can help drive a community-led economic recovery process that we know works.

During a disaster you will have enough on your hands to manage. With Community Futures involved, you can rest easy knowing that we are working with your recovery team, reaching out to small businesses and directing them to available resources in real-time. We will help to ensure your business community gets the help it needs in a way that makes sense.



## What we do for small businesses during a crisis

Community Futures can activate its Crisis Response & Communications Centre at a moment's notice. Our actions will show your entrepreneurs that their community cares, and their government is aware, listening and taking action to support them.



#### Provide an Immediate Assessment of the Situation

Our Business Crisis Response Team will be deployed to connect with local businesses, find out how they are affected and what their needs are.



#### **Begin Immediate Service Delivery for Affected Businesses**

Our team will provide targeted outreach to businesses and facilitate connections to the supports that best address their needs. Our understanding of business means we can help navigate business-centered challenges and provide clarity on options and solutions.



#### Collaborate with you on Joint Advocacy Efforts for Continued Supports

We can work with local government to advocate for further supports from other levels of government.



#### Provide Follow-up Monitoring, Assessment & Support

Months later, we will still be there as a shoulder to lean on for entrepreneurs. We will help them work through the changes they've had to make, navigate insurance claims, and learn to become more resilient to build back better.


Community Futures British Columbia is a provincial association representing 34 Community Futures Development Corporations (CFDCs) in British Columbia.

## 2021 Wildfire Disaster Lytton BC

Partners: 35 members of the Lytton Unmet Needs Committee

Insurance claims from the wildfire that consumed 90% of the township of Lytton totalled \$78 million. Shortly after the wildfire, Community Futures took the following actions:



Interviewed entrepreneurs and generated a Needs Assessment report



Set up a Business Incubator within the Resiliency Centre



Secured funding for 1 Business Incubator employee + 2 Business Liaisons



Met with businesses monthly in partnership with the Province of BC



Worked with partners to provide incentives for new teachers to relocate



Provided business plan and funding program assistance for businesses



### 2021 Atmospheric River Disaster **Fraser Valley BC**

Partners: The Abbotsford Foundation, University of the Fraser Valley, Tourism Abbotsford, Abbotsford Chamber of Commerce

The Insurance Bureau of Canada has estimated the cost of the disaster at \$675 million for damages that were insured. That figure was increased by \$160 million from business claims in areas where commercial insurance was more available.

## 2020/21 COVID-19 Pandemic Province-wide

Partners: All levels of government

The federal government designated Community Futures British Columbia as the only organization to deliver its Regional Relief and Recovery Fund. All 34 BC offices provided repayable loans to businesses that were not otherwise eligible for federal assistance.

## 2018 Flooding Disaster Grand Forks BC

Partners: The Province of British Columbia, Regional District of Kootenay Boundary, the City of Grand Forks, Red Cross, BC Economic Development Association

The total estimated economic impact of the immediate event has been estimated at \$26 million with a projected \$12 million moving forward. The event led to 188 employees being immediately laid off, resulting in \$2.4 million in lost wages. Within days of the crisis, Community Futures had mobilized a team of economic development practitioners around the province to assess impacts to businesses. From this work, \$3.5 million dollars was assigned by the province for revitalization projects, with an additional \$2.9 million assigned for direct-to-business supports.

## 2017 Wildfire Disasters BC Interior

Partners: Multiple municipal and regional governments, the Government of British Columbia, Red Cross, Western Development, Northern Development Economic Trust

Five of BC's worst 10 fire seasons have occurred since 2010. The 2017 fires burnt through 1.2 million hectares of land and caused \$649 million in damages.
